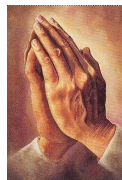

This month's rally was held at the Coffee Creek RV Park in Santo, TX. The attendance was lower than usual, but there was still lots of fellowship and fun.

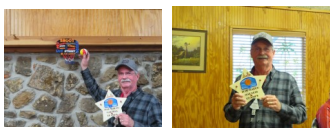


We have been to this RV Park several times in the past. This time the weather decided not to cooperate at all with some really hard rain and chilly weather.

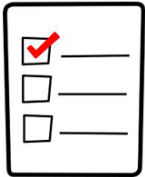

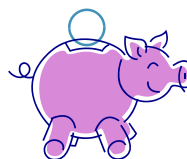
